



## THRESHOLD CLAUSE (ARTICLE 8 OF THE BYLAWS OF SEB S.A.)

Historically, the Company's bylaws provide that any natural or legal person, acting alone or in concert, who comes to hold, directly or indirectly, 2.5% of the share capital or voting rights, or any multiple of that percentage, shall be required to notify the company of the total number of shares they hold within a period of four trading days of crossing one of these thresholds .

The General Meeting of May 20, 2021 adopted, through the vote of the 22nd resolution, the lowering of the threshold for declaring the crossing of the 2.5% threshold to 0.5% or any multiple thereof. This declaration must therefore be renewed each time a new threshold of 0.5% of the capital or voting rights is crossed, whether upwards or downwards. It must also include all the information to be provided to the Autorité des Marchés Financiers in the event that the legal thresholds are crossed.

These notifications must be sent by email to the company's shareholder service and by registered mail with acknowledgement of receipt sent to the company's registered office.
